

FACILITY POINT OF CONTACTS

Policy from NDS for Detainee Transfers: Immigration and Customs Enforcement (ICE) often transfers detainees from one facility to another for a variety of reasons. This standard prescribes procedures and notification requirements to be followed when transferring a detainee. ICE will make all necessary notifications when detainee is transferred. At the time of the transfer, ICE will provide the Detainee Transfer Notification worksheet with the name, address and telephone number of the facility he/she is being transferred to. The detainee will be instructed that it is his/her responsibility to notify family members. This contact list will also be posted on all bulletin boards along with the pro-bono list and the consulate listing.
